3.1 Risks Resulting from Concentrations in Financial Instruments or Issuers

Please note that, in the context of our investment activities, it may exceptionally occur that single financial instruments have a weighting of 10% or higher, and/or that financial instruments issued by one single issuer or investments in correlated sectors, countries, or currencies have a weighting of 20% or higher in the portfolio (see the relevant explanations on concentration risks in the brochure published by the Swiss Bankers Association referenced above, which may arise from such concentrations). The weighting of the single financial instruments and currencies, as well as the respective issuers, is disclosed in the periodic custody account statements provided by the custodian bank.

4. Market Offering and Economic Ties Taken into Account

The market offering taken into account by us in the selection of financial instruments within the scope of asset management comprises a wide range of third-party financial instruments, in particular equities, bonds, units in collective investment schemes (funds), structured products, derivatives, etc. In individual cases, it may occur that we invest in funds managed by companies in which board members or employees of ARTIS PARTNER hold a board or advisory position. As such personal affiliations may give rise to conflicts of interest (e.g. due to the payment of advisory fees that could result in preferential treatment of such products), we have implemented appropriate organizational measures and

contractual provisions to prevent any resulting conflicts of interest. In particular, ARTIS PARTNER applies an investment process based on objective parameters in line with market standards when selecting financial instruments and does not accept retrocessions from these companies.

There are no economic ties to third parties in connection with the services we provide.
